**PRESENTATION:** Concentrated solution for dilution with water.

CRESYLIC ACID	400 g
METACHLOROXYLENOL	20 g

### PROPERTIES:

Cresol (coal tar) is a derivative disinfectant especially effective against acid-fast bacteria, penetrates cracks and dirt layers that may harbour microbes. Metachloroxylenol has antiseptic and germicidal properties and has also the ability to attack mildew that may become established in cracks or crevices in walls or floors. The combination of these active components ensures that **KEYDREX™** is a highly suitable for disinfection of intensive animal housing after de-population.

### DIRECTIONS FOR USE:

LOCATION	USE RATE	GENERAL INSTRUCTIONS
Broiler and other deep litter sheds.	10 L to 200 L of water. (1:20 dilution)	Spray walls and floors when litter is completely removed. If litter is to be re-used, heap to the centre of the shed, spray walls and exposed floors then spray litter after re-spreading. Use approx. 5 litres of diluted solution per 40 sq. metres. Allow 1-2 days before re-introduction.
Cage layer sheds, battery brooders, pig pens.	10 L to 200 L of water. (1:20 dilution)	Thoroughly clean removable feeders, drinkers etc. Ensure floors and drains are free of manure. Spray equipment, cages, walls and floors. Allow 1-2 days before introducing new stock.
Horse and cattle stalls, other livestock housing (walls and floors).	10 L to 400 L of water. (1:40 dilution)	Spray walls and floors.
