Therefore, a balanced diet containing adequate levels of vitamins and minerals is essential for general health, growth, reproduction and lactation performance, feed efficiency and disease resistance.

**KEYMIX® BOAR & SOW™** premix contains a balanced level of vitamins and minerals that will maximise feed nutrient value and utilisation to optimise performance in breeder pigs. In addition, BOAR & SOW premix includes biotin as increased biotin levels combined with zinc and other trace-minerals are necessary for the maintenance of strong healthy hooves in housed pigs, along with zinc, to ensure quality of the hoof.

For the best results, BOAR & SOW premix should be added to breeder rations containing balanced levels of protein, energy, salt, calcium and phosphorus.

### DOSAGE AND ADMINISTRATION:

**Mix thoroughly at a rate of 1.5 kg premix per tonne of feed.** To ensure thorough mixing, add BOAR & SOW premix early in the mixing process, increasing the batch size to the required amount with other ingredients.

**MEAT WITHHOLDING PERIOD: NIL.**

**TRADE ADVICE:** EXPORT SLAUGHTER INTERVAL (ESI): ESI not required.

**POISONS SCHEDULE:** S6 (due to inclusion of selenium).

**REGULATORY STATUS:** EXEMPT.
