**PROPERTIES:** KEYMIX® GLUTACIDE™ is an all-purpose surface disinfectant and cleaner for animal and bird housing. Both active ingredients of GLUTACIDE™ combine to provide strong biocidal activity against micro-organisms. Glutaraldehyde is chemically related to formaldehyde with a similar antiseptic and disinfectant efficiency, but greater safety than formaldehyde. Quaternary ammonium compounds have well-established disinfectant qualities, plus excellent detergent, surface spread and penetration characteristics.

GLUTACIDE™ kills bacteria, fungi, viruses, protozoa and yeasts. It is a highly effective all-purpose surface disinfectant for use in the animal industries. GLUTACIDE™ has a rapid action and remains active for several days on treated surfaces. All animal and bird housing systems may be safely and effectively cleaned and disinfected using GLUTACIDE™. The product is not formulated or intended for use directly on animals or birds, however, but is suitable for all animal contact areas. GLUTACIDE™ is non-staining and non-corrosive.
