PROPERTIES: Piglets should have access to a creep feed as early as 4-5 days of age. **KEYMIX[®] PIG WEANAID[®]** provides vitamins and minerals to fortify creep feeds and to ensure piglets obtain maximum benefit from nutrients in high-cost rations. Early availability of good quality creep feed containing PIG WEANAID will minimise the setback when piglets are weaned from the sow. This will help contribute to heavier weaning weights.

Flavours and sweeteners included in PIG WEANAID, as well as having the creep area near the sleeping area, will encourage piglets to eat more frequently. PIG WEANAID now contains betaine (in place of choline) to improve vitamin stability during storage.

DOSAGE AND ADMINISTRATION:

Mix thoroughly at a rate of 2 kg per tonne of feed. To ensure thorough mixing, add PIG WEANAID early in the mixing process.

CAUTION: Since calcium, phosphorus and salt are easily and cheaply available to the pig producer; significant amounts of these minerals are not included in this product.

MEAT WITHHOLDING PERIOD: NIL.

TRADE ADVICE: EXPORT SLAUGHTER INTERVAL (ESI): ESI not required.

POISONS SCHEDULE: S6 (due to inclusion of selenium).

REGULATORY STATUS: EXEMPT.

PACK SIZES: 10 kg (sufficient for 5 tonnes of feed).
