

EQUINE JOINT SUPPORT FORMULA 2TM

A NATURAL SUPPLEMENT FOR JOINTS WHERE LONG-TERM USE CAN ASSIST IN MANAGING JOINT HEALTH AND FUNCTION.

PRESENTATION: Brick red free flowing powder.

ACTIVE CONSTITUENTS: Each Kg contains 200g Glucosamine Sulphate (Marine Exoskeleton) and 60g Sodium Chondroitin Sulphate (Bovine Cartilage).

PROPERTIES: Equine Joint Support Formula 2 is manufactured using high grade co-crystallised glucosamine sulphate and low molecular weight chondroitin-4-sulphate. The glucosamine is extracted from crustacean shells as glucosamine sulphate, considered to be a more bioactive form of glucosamine than glucosamine HCl. The chondroitin sulphate in Joint Support Formula 2 is of a low molecular weight to ensure its bioavailability. Glucosamine sulphate is the key building block required for cartilage maintenance and repair. Chondroitin-4-sulphate is the major form of chondroitin found in young healthy joints. It is one of the key components that gives cartilage its ability to absorb impact and resist wear.

DIRECTIONS FOR USE: Equine Joint Support Formula 2 is recommended for young and growing horses as well as adult horses that are spelling. This product is suitable for horses in light work with no history of joint disease/injury.

DOSAGE AND ADMINISTRATION: Horses: Initial administration: 50 g (2 level scoops) per day mixed with feed for 4 weeks. For a 500 kg horse the initial dose rate of 50g (2 level scoops) mixed with feed once daily provides 10,000 mg glucosamine sulphate and 3,000 mg sodium chondroitin sulphate per day.

Ongoing maintenance: 25 g (1 level scoop) per day.

For a $500 \, \text{kg}$ horse the maintenance dose of $25 \, \text{g}$ (1 level scoop) mixed with feed once daily provides $5{,}000 \, \text{mg}$ glucosamine sulphate and $1{,}500 \, \text{mg}$ sodium chondroitin sulphate per day.

Higher dose rates may be administered. For a 500 kg horse the highest dose rate of 100 g (4 level scoops) mixed with feed once daily provides 20,000 mg glucosamine sulphate per day and 6,000 mg sodium chondroitin sulphate per day.

CAUTION: Not recommended for use in acute or infectious joint conditions. Discontinue use in the event of adverse reaction (e.g. diarrhoea). Use with caution in pregnant, lactating animals or animals with bleeding, liver or kidney disorders.
