**PROPERTIES:** KEYMIX® GROWAID™ contains scientifically balanced levels of vitamins and minerals to satisfy the requirements of growing and finishing pigs. When used as directed, GROWAID™ is formulated to fortify the nutrients provided by pig grower rations, which contain protein, energy, calcium, phosphorus and salt with essential vitamins and minerals for optimum growths and vitality. GROWAID™ will maximise the value of nutrients in animal diets and optimise feed conversion, efficiency and body weight gain. GROWAID™ now contains betaine to improve vitamin stability during storage.

### DOSAGE AND ADMINISTRATION:

GROWAID™ is indicated for pigs, which are past the weaning stage and entering the growing phase. PIG WEANAID™ is indicated as a creep feed premix for suckers and weaners, prior to the commencement of feeding GROWAID™.

Mix thoroughly 1 kg of GROWAID™ per tonne (1,000 kg) of balanced feed. To ensure thorough mixing, first mix GROWAID™ with about 10 kg of fine feed material (e.g. pollard). Add this during the early stages of mixing.

**MEAT WITHHOLDING PERIOD:** NIL.

**TRADE ADVICE:** EXPORT SLAUGHTER INTERVAL (ESI): ESI not required.

**POISONS SCHEDULE:** S6 (due to inclusion of selenium).

**REGULATORY STATUS:** EXEMPT.

**PACK SIZES:** 20 kg (sufficient for 20 tonnes of feed).
