

# **SULPHATRIM<sup>®</sup>**

BROAD SPECTRUM ORAL ANTIBIOTIC TREATMENT

**PRESENTATION:** A white free-flowing soluble powder.

**ACTIVE CONSTITUENTS:** Each kg contains: **SULPHADIAZINE** 400 g TRIMETHOPRIM

# **PROPERTIES:**

The combination of trimethoprim and sulphadiazine act synergistically to create an antibiotic compound with an exceptionally wide spectrum of activity at low concentration. This allows for use of lower doses of the drug and reduces the possibility of side effects, whilst giving optimum control of infection. The individual actives are bacteriostatic, however, in combination they act synergistically together as a bactericidal.

SULPHATRIM<sup>TM</sup> is useful for the treatment of bacterial infections due to Sulfadiazine and Trimethoprim sensitive organisms of chickens, turkeys, pigs, horses, cattle and sheep especially of the respiratory, urinary and alimentary tracts.

# **DOSAGE AND ADMINISTRATION:**

Restraints: DO NOT USE in lactating or pregnant cows/ewes where milk or milk products may be used for human consumption. DO NOT USE in birds, which are producing or may in the future produce eggs or egg products for human consumption.

### **CHICKENS:**

1 g per 4.5 Litres of drinking water for 3-5 days for *E. Coli, Pasteurella, Haemophilus* spp. or Staphylococcal infections. 3 g per 4.5 Litres of drinking water for 3-5 days for Salmonella spp. infections.

#### PIGS:

3 g per 4.5 Litres of drinking water for *Campylobacter* spp. and *E. Coli* diarrhoea.

#### **TURKEYS:**

15 g per 500 kg live weight daily in drinking water for 3-5 days.

# HORSES, CATTLE & SHEEP:

62.5 mg per kg body weight daily.

This medication is completely soluble in water.

#### WITHHOLDING PERIODS:

MEAT: DO NOT SLAUGHTER for human consumption for the following periods after the last treatment; PIGS: 15 days; POULTRY, TURKEYS, CATTLE and SHEEP: 14 days; and HORSES: 28 days.

MILK: DO NOT USE in lactating or pregnant cows/ewes where milk or milk products may be used for human consumption.

EGGS: DO NOT USE in birds, which are producing or may in the future produce eggs or egg products for human consumption.

TRADE ADVICE: EXPORT SLAUGHTER INTERVAL (ESI): This product does not have an ESI established. For advice on the ESI, contact the manufacturer on (02) 9672 7944 before using this product.

Any variation by the prescribing veterinarian to the approved dose, frequency, duration, route, disease or target species may require extending the approved withholding period.
